## **Before ICE there was INS and before INS there was INA:**

The foundation of current U.S. immigration law is the **Immigration and Nationality Act of 1952**, with major amendments in 1965, 1986, and 1996. The 1965 Act abolished national-origin quotas, while the 1986 Immigration Reform and Control Act (IRCA) legalized millions, making it a pivotal, more recent, major reform.

The Immigration and Naturalization Service (INS) was created on **June 10, 1933**, by democrat President Franklin D. Roosevelt through Executive Order 6166. It was formed by merging the Bureau of Immigration and the Bureau of Naturalization. The INS was dissolved in 2003, with its functions divided into three agencies under the Department of Homeland Security.

George W. Bush was president when **U.S. Immigration and Customs Enforcement (ICE)** was formed. Following the 9/11 attacks, President Bush signed the **Homeland Security Act of 2002** on November 25, which created the Department of Homeland Security (DHS) and established ICE, which officially began operations in March 2003.

Key legislative, executive, and historical details include:

- **INA of 1952:** Codified under Title 8 of the U.S. Code, it remains the basic framework for immigration policy.
- **1965 Amendments (Hart-Celler Act):** Replaced quotas with a system prioritizing family ties and skilled labor.
- **1986 (IRCA):** Addressed illegal immigration through employer sanctions and legalized residents who entered before 1982.
- **1996 Reforms:** Significant updates to enforcement and removal.
- **Executive Actions:** In 2012, the Obama administration implemented DACA, affecting immigration enforcement, which has been subject to legal challenges.

These laws are still in effect, heavily amended, and constantly interpreted through Supreme Court rulings and executive branch policies.

Democrat President Obama was termed the “**Deporter and Chief.**” The Obama administration deported more than **2.5 million to 3 million people** between 2009 and 2016. Yet, no media called him or ICE Nazis, in fact there were many reporters filming and reporting on their “*ride-alongs*” with ICE agents. ICE agents did the same thing then, as ICE agents do today.

Current U.S. immigration law is primarily governed by a foundation established in **1952**, which was significantly overhauled in **1965**. While Congress has not passed “comprehensive” immigration reform since **1986** or **1990**, it continues to pass narrower laws affecting specific enforcement and visa policies through 2025 and 2026.

I know this is difficult to comprehend, but before you blame President Trump for the deportations, perhaps you should look at who is fighting them and question why?

Notice that neither a Democrat led nor Republican led Congress have bothered to “reform” the immigration laws. President Trump and ICE are simply following the laws that are in place.






