1. I read with interest your article "District Court en bancs". This is a proposal to advocate the greater use of district court en bancs at the most propitious time:

a. Currently, dozens of federal district courts are facing the real prospect of having their orders disregarded as a matter of policy by the Trump administration with the approval and encouragement of its two top officers. So, VP JD Vance stated on February 8, that "Judges aren't allowed to control the executive's legitimate power"; and thereafter the President posted on his Truth Social media that "He who saves his Country does not violate any Law."

b. A district court en banc order directing the administration to comply with the law can strengthen the validity of a single district judge's order by weakening the pretense that if such a judge decides against the administration, she is 'a corrupt and biased so-called judge'. The order can gain in validity faster and more cheaply than through a circuit court affirmance.

a. It seeks to expose the practice of Medicare and healthcare insurers to evade coverage claims through their 'delay, deny, defend' tactics. That triptych of abuse of power is reminiscent of the one that Luigi Mangione furnished as the insurers' conduct justifying his killing of UnitedHealthcare CEO Brian Thompson in NYC on 4 Dec. 2024.

3. I referenced your article in my [motion for reconsideration](#) ♦ of the district judge's order of service of the summons and complaint. On her own initiative, she dismissed all the individual defendants in my complaint. I have charged them with coordinating their 'delay, deny' tactics to wear me down through the four levels of administrative appeal through which I had to proceed for more than three years until reaching the fifth level of judicial review; e.g.:

a. coordinating the insurers' failure to provide discovery, file a brief, or appear below;

b. coordinating Medicare's disregard of its statutory duty to decide an appeal like mine in 90 days;

c. coordinating the no-reply to my emails requesting discovery and a decision that I sent daily to eventually more than 30 officers so that by the time the decision was issued they had disregarded more than 11,500 emails from me!; etc.

4. You and your students may be interested in this case because there are more than 67 million insureds by Medicare. To qualify as such, they must be old, sick, disabled, and/or affected by certain chronic diseases. The overwhelmingly majority of them lack the physical stamina and emotional and financial resources, let alone the legal know-how, needed to go through five levels of appeal, never mind to a sixth in a court of appeals. They are easy prey of Medicare; a big insurer like EmblemHealth, with more than 3 million insureds; and a huge claim denial reviewer like Maximus Federal Services.

5. Your School may also be interested because on its [website](#) it states the following:

Experiential learning at Cornell Law School is a central part of our educational model. A robust set of clinical courses helps students move beyond the classroom into the world of practice; the Lawyering

Program focuses on teaching the real-life skills employed by practicing attorneys, and externships around the country...put classroom learning into practice.

6. My proposal is for you, your students, and Cornell to help the abusees by Medicare and its insurers' 'delay, deny, defend' tactics by taking the lead in holding [unprecedented citizens hearings](#).

a. The citizens hearings will afford the opportunity to abusees and the audience, whether through physical or digital attendance, to tell and listen to the story of the abuse that each has suffered or witnessed due to 'delay, deny, defend' tactics. Each can compose his story by applying the [two-phase method](#) ♠ for writing it in up to 500 words and in a way intended to make it accurate, significant, verifiable, and helpful in detecting patterns of abuse.

b. The hearings are to be moderated by professors, students, journalists, media outlet anchors, IT/AI experts, fraud and forensic accountants, statisticians, public interest advocates, etc.

c. Their venue will be school auditoriums and media stations.

d. There they will be held live and from there they will be transmitted via the Internet to make them accessible to everybody elsewhere. As people listen to the stories, they will shout 'that happened to Me Too!' and ask to tell theirs, making the hearings self-reinforcing.

e. The hearings can spread to other schools, as did the [campus encampments](#) and the protest against [then-Judge Kavanaugh](#).

7. The citizens hearings and their expansive [plan of action](#) can spark the formation of a powerhouse centered on academe and the media. It can force reform so that instead of district courts dismissing powerful defendants, thus protecting them from even having to appear in court, let alone defend, they begin to administer justice with transparency, accountability, and liability to abusees.

8. This is a realistic expectation because, as you wrote in your article, district court en bancs are held without any statutory mandate or procedural rules adopted by the Federal Judiciary and Congress.

9. Moreover, as stated above, it is in the interest of the district courts to increase the validity of the

orders of their single judges by adding to them support en banc.

10. In addition, the marshals are no match for January 6-like rioters, not to mention the army obeying the fiats of a lawless administration. By the district courts protecting the millions of an ever-older and sicker population; the defrauded by false promises; and employees and minorities targeted for capricious and arbitrary termination, retribution, and discrimination, they can earn the reciprocal protection of We the People.

11. The hearings can also provide the basis for a multidisciplinary clinical course in the public interest. There law, journalism, and IT/AI students can acquire the "experiential learning" that will enable them to open upon graduation a boutique dedicated to a new form of practice: representative journalism. It is described at [OL3:1750§b](#)♣ of my three-volume study of judges and their judiciaries:

12. At [1751](#), you will find the blurbs and abstracts of other cases that I have made ripe for class action. They affect large groups of people who lack the means and the knowledge to access the courts individually.

a. Among them are educated, successful, and influential people able to read demanding articles like this. They have visited my website, Judicial Discipline Reform, at <http://www.Judicial-Discipline-Reform.org>, where I post some of my articles. So many visitors have reacted so positively to them that as of 14 March 2025, the count of subscribers was **54,094**.

b. They can be reached out through my site and asked to support the greater use of district court en bancs.

13. I respectfully request that you give practical application to your article by asking as an amicus

curiae that Judge Jeannette A. Vargas, assigned to the case, and Chief J. Laura Taylor Swain review en banc the service order and my [motion for reconsideration](#) ♦.

14. In turn, I offer to present my proposal for citizens hearings, a clinic, a new form of practice, and my other cases to you, your colleagues, and students, in person if the School covers my expenses and fee; otherwise, via video conference.
