- 1. This is a proposal to join forces in support of your client Luigi Mangione and all healthcare insureds who have been or risk being victimized by healthcare insurers' abusive claim evasion tactics, pithily described in the paraphrase 'delay, deny, defend'.
- 2. While the evidence that keeps being found against Mr. Mangione makes it ever more probable that he will be unable to win his freedom, we can help him save his objective: expose insurers' abusive 'delay, deny, defend' tactics.
- 3. His use of that description has provoked in the public, not condemnation of him, but rather outrage at the industry. It can gain Mr. Mangione the extenuating sympathy of the public, the jury pool, the jury, and perhaps even the judges.
- 4. We can jointly exacerbate that outrage by using the complaint/appeal that I have written with that word triptych illustrating those tactics. I recently filed it as:

Cordero v. Secretary of Health and Human Services, Medicare, <u>Emblem</u>Health [health insurer], Maximus Federal Services [reviewer of insurance claims denials], et al. [including many of the top officers of the Medicare Appeals Council and the Office of Medicare Hearings and Appeals (OMHA)]; docket no. 24-cv-9778-JAV filed in U.S. District Court, SDNY, on 16 December 2024.

- 5. Emblem medically insures more than <u>3 million people</u> in NY City and the rest of New York, New Jersey, and Connecticut. Maximus performs for Medicare reconsiderations of health insurance companies' denials of their insureds' medical services and equipment claims.
- 6. These entities have their own but harmonious interests:
- a. Medicare wants to attract to, and retain in, its network the largest number of medical insurers, whose decisions affect the options of millions of people. Emblem, like the other insurers, wants to pay as few claims as possible.
- b. Maximus, a so-called qualified 'independent' contractor, works for Medicare in a principal-agent relation, but not for long if it routinely reconsidered disapprovingly claim denials, thus causing the other two entities to be liable for the claims.
- 7. The typical Medicare insureds whose claims were denied are old, disabled, sick, and ignorant of the law. They can hardly afford a lawyer or muster the energy needed to go through four administrative levels of complaint and appeal until reaching the fifth level, that is, judicial review in

- the U.S. district court. Accordingly, most insureds just take the abuse sooner rather than later. If able at all, they scribble a whining personal anecdote with no legal arguments...and are wiped out by the healthcare insurers' army of lawyers.
- 8. By contrast, the case that I filed analyzes the functioning of a healthcare system rigged through complicit coordination by Medicare, the insurers, and their medical services and equipment providers. This functional exposure can benefit you, Mr. Mangione, and me by turning him and my complaint into a rallying point by means of self-reinforcing cycles:
- a. The more the complaint is described at press conferences, in press releases, at interviews, and in published articles, the more it will inform the public about the industry's abusive tactics, the more people will become more outraged and many will scream, "That happened to *me too!*"
- b. They will want to advance their quest for justice and compensation by telling their <u>story</u>2. We will promote the holding by media outlets and universities at their stations and auditoriums of *unprecedented citizens hearings*.
- c. The citizens hearings will afford people the opportunity to tell their story in person or online to the national public.
- d. Your case and mine in SDNY can rally ever more people that demand the citizens hearings. A more informed and outraged public will energize another self-reinforcing cycle.

9. This information and outrage cycle is fostered by my website at <u>Judicial-Discipline-Reform.org</u>. There I post <u>articles</u> of my three-volume study of abuse of power, the product of my professional law and business research and writing, and strategic thinking. State officials assume authority under a dictum known as *Parens patriae* – translated to mean government has authority over a nation. For "Us, the American People," there were founding, not parental fathers.

<u>America's Founding Fathers Crafted America's</u> government so individuals, as a sovereign citizenry, are empowered to limit government authority as such sovereign citizenry shall decide. "Our, the American People's legislators, magistrates, and government chief executives have presumed to decide how America's commonwealth, federal, (U.S./National), and state Constitutions shall be interpreted.

**Power To Interpret Constitutionality Negates** limited government by sovereign citizenry authority. For education,, Constitutionality interpretation lets state officials override parental authority. "We, the American People" are, thus, reduced to subjects, not citizens. State authority over education means state officials, not parents, define behavioral outcomes. Education has one object – behavioral control.
