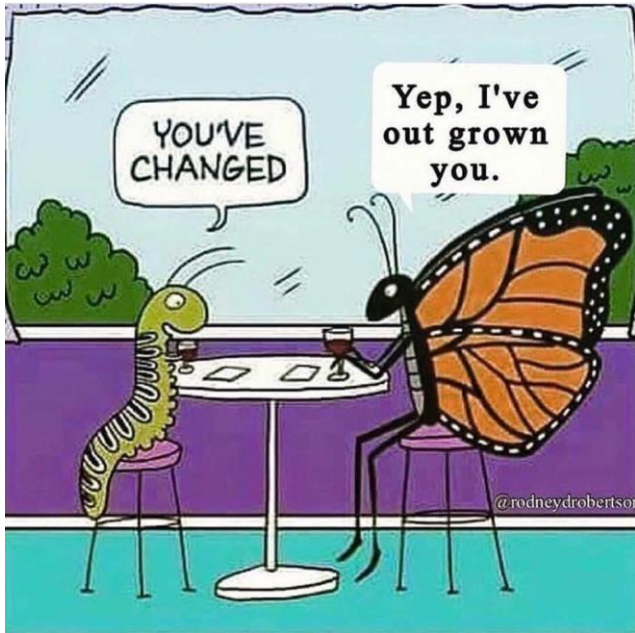


"We, the American People" have been treated to unreliable court decisions since America's courts started making decisions. Free societies can not afford to allow court decisions to rule without

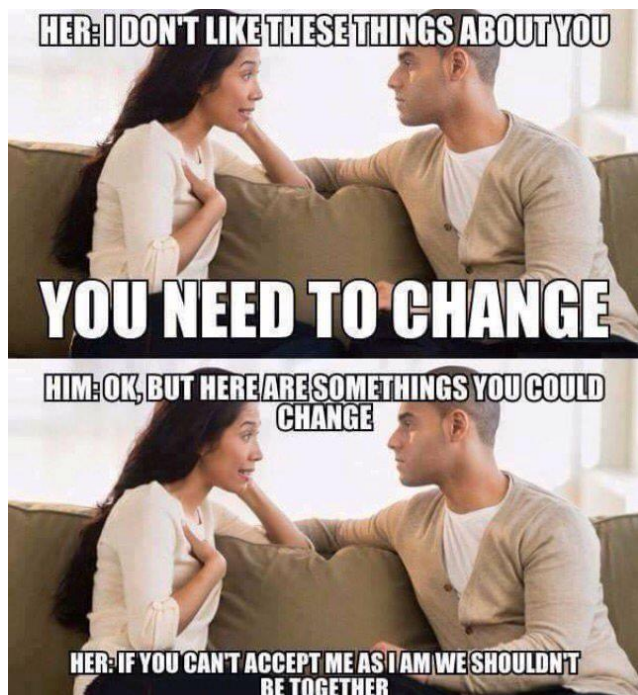
