Dear President Mills and Provost Dopico,<sup>1</sup>

1. In your oral "[Message of the President](#)", you say that you have "insatiable curiosity" and are in quest of "what justice could look

like". This is an appeal for you to direct those drivers of your personal and professional character so that as university president and social worker you "tackle the issue [not] of domestic violence", but rather of public abuse of power by the director of the NYU General Dentistry Clinic, Dr. Byrd, et al.; and its condonation by Dean Charles Bertolami and Public Affairs Dean Elyse Bloom. The details are provided in the attached letter, summarized thus:

2. Put yourself in the social situation of a patient and like you a doctor of law. You go to your dental clinic with an emergency and a financial constraint to document to you HMO "medical necessity" and receive preauthorized service before the end of the year. You obtain from the attending doctor -Dr. Robin- the authorization to have X-Rays taken: a panoramic of all your teeth and a bitewing series of individual teeth.

a. You have the first taken downstairs and come back up to have the second taken. But the director, who has never spoken to you and you have never seen, comes to the public area, the reception, and orders you to make an appointment or she will call security to have you removed. You try to explain your medical and financial situation...and she actually orders a receptionist to "call security to remove a person that refuses to leave!"

b. To de-escalate, you make the appointment, upon which you leave humiliated and abused. Are you shocked by being treated in public, with no discussion of reasons, as threatening clear and present violence so that removal by security is warranted? Your family history may make being publicly humiliated and abused painfully realistic.

3. That happened to me at the NYU College of Dentistry on Friday, December 8, 2023. I wrote the attached letter and on the

11<sup>th</sup>, faxed and emailed it to Dean Bloom, and called Dean Bertolami's office at (212)998-9205 to ask for his fax number. There Ms. May said that he did not have a fax number and in any event, he did not deal with such matters. She put me on hold. When she came back, she said that Clinical Affairs Manager Janice (Jana) at (212)998-9217 would deal with the matter.

a. Mgr. Jana took my call and after I told her that I had described the incident in a letter and would like to email it to her, she gave me her email address as [Dental.ClinicalAffairs@nyu.edu](mailto:Dental.ClinicalAffairs@nyu.edu). I gave her the link to the letter with exhibits<sup>2</sup> and she downloaded it. I stressed the urgency of taking action before the close of the College on December 15. She said that she would review the matter and have a resolution of it before that date.

b. In each of the following days, I emailed and faxed my letter to Mgr. Jana and Deans Bertolami and Bloom; and called them, including Ms. May, but my calls went straight to voice mail, where I recorded messages. They did not respond to me at all.

4. On December 15, at 5:56 p.m., after the College had closed and I would foreseeably have left my office, Director of Patient Advocacy and Social Work Alyson Leffel (tel. (212)998-9875), who had not spoken to me, stated in her first email to me "Please allow 7-10 days for us to investigate these issues and get back to you." Her email was not sent after exercising due diligence: At the top of my letter, I had written in bold "**Re: Urgent matter to investigate while memories are fresh and a remedy is possible.**"

a. Had they proceeded in good faith, they would have walked on Monday, December 11, to the General Dentistry Clinic on the 4<sup>th</sup> Floor and talked to the people identified by name and/or title in my letter as well as receptionists and students. It is reasonable to expect that after two and a half weeks of Christmas recess, people may allege that they do not recall such incident or its

details. Dir. Leffel's 'advocacy' was for her colleagues, not me, part of a cover-up.

5. Financial abuse is shown by the attached bill: Two years after my last visit to the College, a bill was generated out of the blue, for it states that on four occasions the "current balance" was \$0.00. It has no date or medical billing code; no American Dental Association (ADA) code; no indication of the tooth and surface treated; no procedure description; not even an NYU charge; merely a capricious and arbitrary \$105 Patient Balance.

a. On that basis, the General Dentistry Clinic manager, who refused to state her name but others called her Desiree, denied me further service on December 8 and any appointment until I had paid the bill. I asked to see the director. The latter, who also refused to state her name -Dr. Byrd-, ordered me to make an appointment or be removed by security!

6. The HMO EmblemHealth (Emblem) supervisor of the Grievance and Appeals Department, Sean Hillegass, tel. (646)447-0617, essentially repeated in his letter to me of 19 December 2023, what he had stated after I first lodged a complaint with him about this bill and had to resubmit it:

In regard to the bills you received, we contacted all the providers related to the bills you forwarded to me, and we have ensured they all have your correct Medicaid information so they can bill Medicaid for the cost share applied to our EmblemHealth claims and cease billing you. All bills have been adjusted, and you should not receive any further invoices for the dates of service provided.

One caveat to the above was the bill you received for \$105 from the New York University College of Dentistry. I have made repeated attempts to contact them to identify what date of service this bill was related to, and whether a claim was submitted to DentaQuest, our previous dental vendor. I was able to confirm that this was for periodontal services you received in their periodontal division on November 15, 2021, but I was not able to identify any claims that were submitted for these services.

I have left repeated messages with the practice manager in the periodontal division, requesting that they cease billing you, and to return my call to discuss this issue. To date, I have not received a response. I will continue to follow up with their office, and if you receive any additional bills, please forward them to my attention.

7. The College's handling of the bill and its failure to respond to Emblem's inquiries and to my calls, emails, and faxes<sup>2</sup> evince a pattern of indifference and financial irresponsibility, aggravated by balance billing, i.e., the illegal practice of a medical provider of charging the patient for the amount of its bill in excess of what the provider agreed to accept as full payment from, and as a condition of membership in, Medicare, Medicaid, and insurance companies, whose schedule fees may be a fifth of what the provider bills for.

a. When balance bills are received by regular patients, who are neither lawyers nor want to challenge authorities and defend their rights, they either pay or receive no further medical services; are sued; have their credit bureau reports impaired for years by a delinquent notation; and may have to cut back on food, medication, and rent. That is the path to medical bankruptcy. Those patients are abused.

b. Such abusive billing together with the humiliation and abuse above-mentioned are condoned by Deans Bertolami and Bloom. Their unresponsiveness to my daily communications since

December 11 show that they do not care about patients and are inapt to instill in students responsibility for patients. You have notice. They are now your liability.

8. Your understanding of "trauma, resiliency, and recovery" should guide your response to "what justice *should* look like", not just for me, but for all patients and NYU's public image. It should include taking the **Action Requested** in ¶9 of my letter, with the bitewing series taken at no cost to me or my HMO. In your Message you said "I want to hear from you...to listen and ask questions". I can meet you in your office or via video conference, when we can decide whether I should keep my January 11 appointment without fearing more abuse and retaliation.






