





Dear Ms. Leffel,

I am in receipt of your email of March 1, 2024.

I am attending the clinic under the supervision of Dr. Berkowitz on the 5th floor due to the callous indifference of both Dean Charles Bertolami and Dr. Byrd, the director of the General Dentistry Clinic on the 4th floor, to even acknowledge receipt of my emails since the first one on December 10, 2023, reproduced hereunder and downloadable through the email address below[‡], let alone address the issue of the public humiliation and abuse of power that Dr. Byrd inflicted upon me.

I, as a prudent and responsible person, chose to attend Dr. Berkowitz's clinic thereafter in an effort to deescalate and avoid the risk of retaliation if I kept going to Dr. Byrd's clinic.

If you are a genuine patient advocate, then I already 'reached out directly to you' by emailing to you too that 10 December email et seq. and stating the concrete action that I requested be taken. Yet, when we subsequently spoke on the phone, you had not even read my emails and did not know what issues I had raised therein.

E.g., as a result, I had to reach out to my health insurer at the time, EmblemHealth, to request that it cause the withdrawal of a \$105 bill so capricious and arbitrary that it lacked a description of whatever was billed for, its medical billing code, its date of provision, the identification of the billing department, etc.

If you are the advocate of Dr. Bertolami, Dr. Byrd, and the rest of the College staff, you knowingly mislead me with the pretension of your being my advocate; and have already left me alone to fend for myself. In that event, you have no standing to ask that I "reach out directly to [you]" to the exclusion of anybody else.

Dear Dean Bertolami and Associate Dean Bloom,

1. In your "" on your School website, you invited your readers to " ". (emphasis in the original) So, imagine yourself living the experience that I had in your School on December 8. As you read its description, ask yourself: Message from the Dean. Imagine a world in which everybody smiles....The core

aspiration that makes NYU Dentistry different...is that indefinable **something more** that people expect in a doctor, such as being ethical, sympathetic, and caring in their relationships

- a. Would you have felt then and still feel now that the doctors and staff that you met had been "sympathetic and caring in their relationship" to you, never mind "ethical", when an attending doctor authorized panoramic and bitewing X-Rays, but then arbitrarily cancelled the bitewings and when you tried to find out why the director of the clinic, with whom you had never spoken, came to the registration area angry at you, refusing even to state her name, and publicly instructed the registrants to call security to remove you forcibly therefrom?!
- b. How humiliated would you have felt as the victim of such outrageous public abuse of power? Would you have come out of your School 'smiling' or rather shocked by such blatant denial of your right to "be treated with consideration, respect and dignity" 10 NYCRR, §751.9?
- 2. A brief statement of facts follows: I am a patient of your School; my chart number is 537687. Sometime ago, a crown was set by your students and doctors on tooth # 19. It came off. A panoramic and bitewing X-rays taken at the time showed that the root had cracked and the alveolar bone was infected. The Periodontology Clinic estimated that extracting the root, performing curettage, reconstructing a base, and making and setting a crown would cost upwards of \$6,000.
- 3. My HMO refused to pay. Worse yet, at the last moment, it has informed me that it is terminating at the end of this month the health insurance plan that covers me and that I it is up to me to find a similar one with another HMO. The new HMO requires a panoramic and bitewings to conduct its own evaluation of my condition and determine the necessary treatment and what it would cover, which will not exceed a meager \$1,500. To leave that amount available for treatment, the panoramic and bitewings have to be taken in December so that the current plan may pay for them.
- 4. On Friday, December 8, I went to the General Dentistry Clinic on the 4 floor to be treated on an emergency basis so that your students and doctors could determine the gravity of the infection that was causing the flair-up of pain in # 19 and take the necessary diagnostic X-Rays that I could submit to my new HMO for it to start an evaluation process that in any event would take weeks. th

- 5. Student doctor Diana Alomaja was assigned to me. She remarked that the gum was growing over the root of tooth # 19; and using a mirror, showed me that when she pressed it down with a scaler, blood came out. I told her that while I understood that she could not perform a transplant in one visit, at least she could take the required X-Rays. Student Alomaja was sympathetic enough to consult with her attending, Dr. Robin. The latter realized my physical and financial predicament and authorized the panoramic and the bitewings.
- a. Student Alomaja took me to the Periodontology Clinic. Clerk Ms. Jones told us that just the preliminary process of assigning a student to my case would take two weeks. She suggested that I be taken to the 1 floor for the panoramic to be taken. We went to there. After a long wait the panoramic was taken. But Student Alomaja said that she was late for her next appointment and could not take the bitewings. I was left to fend for myself.
- 6. I went to the Periodontology Clinic and appealed to manager Whitney to take the bitewings. She repeated what Clerk Ms. Jones had said. So, I went back to the General Dentistry Clinic and showed clerk Desirée the printed panoramic and asked that she have another student take the bitewings, a process that I knew from experience would take only some 15 minutes. She refused, arguing that protocol only allowed for one procedure to be performed in an emergency visit.
- a. Would you have felt it "sympathetic and caring" to be told that protocol had to be given precedence over your well-being as a patient so that your physical predicament would prolong for weeks and your financial one become permanent?
 - b. Did her statement show "consideration" ‡? That cannot be imagined.
- c. I asked to speak with the office manager. Clerk Desirée walked to her manager and talked to her.
- 7. The manager walked up to me. I asked her name, but she refused to state it. She asked me to step with her outside into the registration area. She said that no further treatment would be given to me and no appointment would be made for me because she had found that there was an unpaid \$105 bill on my account.

- a. I asked her what the bill was for; what its medical billing code was; what was the date of service. She did not know anything about it. She even ignored that I had not been to the School in more than two years! I told her that whoever was the issuer of that bill had to submit it to my HMO, which had paid for all the treatment that I had received in the School over the years.
- b. As we were talking, Dr. Robin walked in front of us. We both called out to her. But Dr. Robin walked past us. When she walked back, we again called out to her. But again Dr. Robin ignored us.
- c. I asked the manager to let me speak to the Clinic director. She went to speak with the director.
- 8. The manager came back with a person in a white coat and both stopped by registrant Ms. Syreeda. I walked up to them.
- a. The person in white said that no further treatment would be given to me and that I had to leave. I asked her name. She would not state it. She said that she was the director and that I either made an appointment or she would call security to remove me! I tried to explain to her that the manager had said that no appointment would be made until I paid the outstanding bill. She threatened me with calling security if I did not leave. I tried to explain that Dr. Robin had authorized the bitewings and that a panoramic had been taken. The director said that Dr. Robin had not authorized such thing. Instead of hearing my side of the story, the director instructed Ms. Syreeda to "call security to remove a person that refuses to leave!"
- b. Trying to deescalate, I asked Ms. Syreeda to give me an appointment; she did. I had not given the director, whose name Ms. Syreeda said was Dr. Byrd, any motive to treat me with such 'disrespect and lack of dignity', let alone do so in public. ‡
- c. Dr. Byrd humiliated me with her abuse of power against me. She defamed me by acting as if I presented such a threat as to justify calling security on me.
- d. How does a person so intemperate and biased treat students, Joe, and Jane if she so treats a doctor of law? Dr. Byrd is now your liability.

- 9. **Action requested**: I respectfully request that you exhibit "moral clarity" regarding your "core aspiration...that your doctors be ethical, sympathetic, and caring", and cause before the term ends:
- a. Dr. Byrd to recognize that she treated me wrongfully and apologize publicly;
- b. Dr. Robin to state whether she unethically denied her X-Rays authorization and, if so, apologize;
- c. I be called and asked to go to the School for the bitewings to be taken by December 15th;
- d. the \$105 bill be withdrawn as stale and lacking essential information to be valid;
- e. I be assured that there will be no "reprisal" against me when I am treated at your School.

I look forward to hearing from you in a timely fashion.
