Dear Mr. Llamas, reporters, Mr. Panlilio and Reuters Business Development officers,

Thank you for your kind call this morning and for your willingness to review

my business development proposal and bring it to the attention of your superiors.

1. I worked at Thomson Reuters's Lawyers Cooperative Publishing (LCP) as a researcher-writer for ALR Fed (American Law Reports, Federal). I left LCP to attend The University of Michigan Business School, where I earned a Master's in Business Administration. This is a proposal for a business and a venture that can benefit Thomson Reuters, others, me, and millions of insureds.
2. I propose that Reuters Business Development gain access as a sponsor to the **63,051+** subscribers to my website Judicial Discipline Reform at <http://www.Judicial-Discipline-Reform.org> as of 27 April 2026, in exchange for compensation and the granting to me of access to WestLaw services and books.
3. My website subscribers read the articles that I write in long form, that is, consisting of more than 1,000 words...and ask for more. They are interested in the intricacies of the law and the way I discuss them. It is reasonable to expect them to be intellectually demanding and certainly educated, influential, and well-off. They can afford Reuters's products and services as well as those advertised by third-parties, be they law-related or addressed to other needs of affluent people(C infra).
4. Convinced by experience of the substantial usefulness of Reuters's offerings for finding and arguing the law, I have praised them in a series of articles.¹ The latter and similar ones are collected in my three-volume study² exposing abuse of power; collectively demanding compensation; and setting in motion a national movement for transformatively reforming the system of justice.
5. Just as my study exposes abuses of power by the judiciary and other public and private entities, so did Reuters in its series of articles exposing the riskless abuse of power by state judges and the state commissions charged with supervising their conduct([OL3:1825](#)). It described them as intertwined by "hardwired judicial corruption". It titled the series "***The Teflon Robe***".([App:6§C¶491](#))³

6. This is the most opportune time for us to join forces on behalf of the [69.9 million insureds](#) abused by Medicare and its healthcare insurers. They coordinate their running of an insurance fraud scheme whose modus operandi centers on committing claim evasive “delay, deny, defend” tactics.
7. That word triptych has been made known by Luigi Mangione. He allegedly killed the CEO, Brian Thompson, of United Healthcare on 4 December 2024. His impending trial will attract journalists from NYC, NYS, the rest of the country, and abroad. We can benefit by interesting them in investigating an angle unavailable to Mangione as justification for murder: how Medicare and its insurers abuse their insureds with those tactics because they are old, sick, disabled, and ignorant of the law.
8. The joint venture’s timing is optimal: Mangione’s trial will be held in the federal court where I am prosecuting a civil case⁴ intended to be a test case in the public interest of exposing, not the abuse inflicted on one insured, but rather how those tactics work(⁴[SDNY:156§L](#)) and abuse millions.
9. The strategy(§A, B infra) aims to turn my website from an informational source into a rallying point where an informed and outraged public organizes to compel primaries and mid-term elections candidates to make this issue a key one of theirs; hold public hearings; and undertake reform. I offer to present it to you and your guests, whether in person if in your NYC offices, or anywhere else if my expenses and fee are covered; otherwise, via video conference.

So, I look forward to hearing from you.⁵
