Dear attorneys Mark, Reynolds, Janove, and Cowart; APA & NYSPA officers; and class plaintiffs,

- 1. I have learned that you have filed a class action against EmblemHealth (hereinafter Emblem) in the U.S. District Court, SDNY (SDNY).**
- 2. I have an action against Emblem pending there. From it, I have taken two interlocutory appeals to CA2.[1]**
- 3. We have common interests in holding Emblem accountable and liable. By joining forces, we can advance them...and even achieve more.**
- 4. Indeed, your case deals mostly with [ghost networks](#) of mental healthcare providers.**

5. My case began with a healthcare claim-triggering event on 8 September 2021. It went from hand to hand of 19 supervisors[2] in Emblem Customer Service call centers in The Philippines and the U.S. while they pretended to be 'researching' what Emblem would cover.

6. For over three months, they engaged in this "delay" tactic through which Emblem tries to wear insureds down and cause them to abandon their claims.(156 infra↓)

7. Since that did not happen, Emblem engaged in its "deny" tactic. I had to climb through the four levels of Medicare administrative appeal, i.e., redetermination, reconsideration by Maximus Federal Services (Maximus), administrative law judge (ALJ) hearing, and an appeal to the Medicare Appeals Council.

8. The Council was required by law to decide my appeal within 90 days of my filing it. However, I had to send eventually to up to 30 top Medicare and Council officers more than 11,000 emails for the Council to decide my appeal two years later.

9. Neither "defended" in a brief; yet, they were not defaulted. I sued them in SDNY District Court.

10. Then the unimaginable happened that should worry you: The judge assigned to my case is J. Jeannette A. Vargas, a 22-year veteran of the USDA's Office, SDNY (the Office), who had risen to deputy chief of its Civil Division. The AUSA assigned to this case was her subordinate there, and the chief appellate attorney assigned to my appeal to CA2 is her "personal friend". But she did not recuse herself to "avoid even the appearance of impropriety", as judges are required to.

11. Far from it, Judge Vargas allowed Emblem's deputy general counsel (DGC) to answer my complaint by rubberstamping the boilerplate "lack of knowledge and information" to deny practically each of its paragraphs. However, Emblem had dealt with my case for years since its inception on 8 September 2021. What is more, that DGC was the one who represented Emblem at the ALJ hearing so that he had, not only institutional, but also personal "knowledge and information" of everything stated in my complaint.

12. Worse yet, Judge Vargas allowed the AUSA to make common cause with Emblem by copying its answer and signing it as her own and the USDA's. However, the AUSA's and Emblem's "knowledge and information" of the case are not coextensive and the USDA has power of subpoena and search and seizure to investigate any case.

13. Judge Vargas committed a glaring impropriety by allowing the USDA Office -her employer for over two decades and a law enforcement authority- to make common cause with Emblem, the entity on which you expect the law that you cited in your causes of action to be enforced by the Office.

a. When the investigator and its investigative target make common cause, the independence necessary for the former to perform its duty is impaired and the ability of the latter to offer a bribe is enhanced. Their opposite interests give way to common interests. Advancing them together generates indulgence that replaces accountability and produces a cover-up. The resulting complicity forms the basis for running a shared corrupt enterprise.

b. The USDA and Emblem jointly raised a motion for judgment on the pleadings against me. The USDA's Office and the SDNY chief district judge never replied to my complaint about this grave conflict of interest and dereliction of duty. Both showed depraved indifference to actions compromising their personal and their respective office's integrity, impartiality, and confidentiality.

14. Though the judge in your case is a different one from the one in mine, Emblem has now a 'partner' inside the District Court and the Office.(701↓) It can learn ex parte what can make it decide to settle or keep fighting us.

15. Emblem may belatedly disclose where it stands on any issue on which it claimed to "lack knowledge and information". Thereby it will commit the unfair surprise that is inherent in its tactic to "defend" at its convenience regardless of any deadline imposed by procedural rules. But it will not surprise Medicare.

16. Medicare has known for decades that Emblem and the other insurers that accept the Medicare insurance and providers on its network coordinate the plotting and commission of their "delay, deny, defend" tactics to evade paying their insureds' claims.

a. Medicare tolerates, condones, and coordinates those tactics because it is in its interest to maintain and enlarge its own network in order to keep and attract as many insurables as possible. Together they commit those tactics as the modus operandi of their healthcare insurance fraud scheme through which they run their racketeering organization and corrupt enterprise.

17. Medicare has [70.2 million insureds](#)[3]. They are old, disabled, affected by certain chronic diseases, and law-ignorant. They are easy prey to those tactics due to the connivance of Medicare with Emblem and others. Hence my suing Medicare too.

18. Public outrage can support our cases. It can be stoked by joining forces with [other lawyers](#) and community leaders to approach the many [journalists](#) from NYC, NYS, the rest of U.S, and abroad who will be in and around the courthouses where the trials of Luigi Mangione will be held, beginning with the state trial in September.

19. This can lead to unprecedented citizens hearings[4]; the largest class action ever; and transformative change in the healthcare, insurance, and justice systems.

20. I offer to make a presentation thereon to you and your guests in your offices or via video conference.[5] Accordingly, I look forward to hearing from you.

Dare shout "*I accuse!*"...
