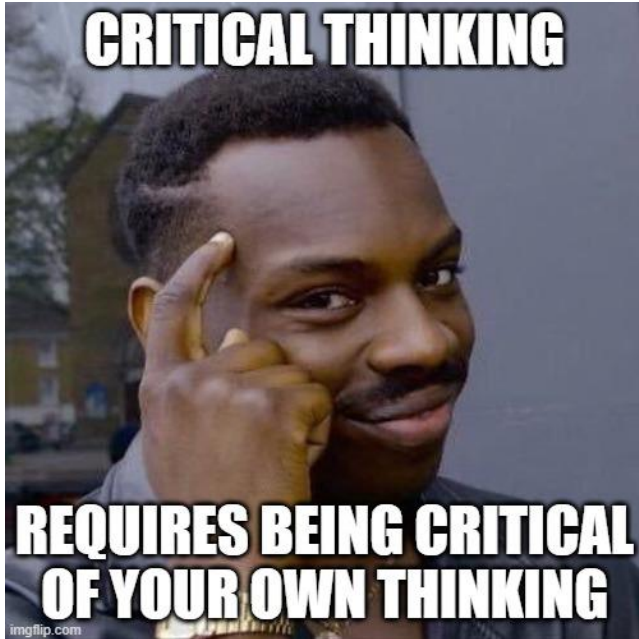


US Tourism By Canadians Is Hurting, all because of “Our, the American People’s” President Donald

Dear Mrs. Jodi and Advocates of Honest Judiciaries,

Thank you for your very good ideas in red characters and below.

1. It is a good idea to have the attendees introduce themselves, but they should do so in writing. Imagine that you and Mr. Rouviere tell your respective colleagues about the presentation and the number of attendees climbs to 15. Their statement will take too much time and nobody will remember what everyone can do.

2. The presentation should follow the model of a Continued Legal Education (CLE) seminar. I have attended some that have had more than 3,000 attendees. We do not want to establish the precedent that at my presentations attendees can introduce themselves live. They can choose to do so in their up to 500 words story. Making it hard to tell their story will be a way of identifying the most committed attendees, who are willing to put in the effort and time necessary to tell it in writing.

3. The presentation can be had on a Saturday at 11:00 a.m., especially if there is the possibility for people from the West to attend. It is reasonable that they can be up by 8:00 a.m. if they want to attend live a presentation that begins at 11:00 a.m. on the East Coast.

4. In whatever city or state a person lives, there he or she can form a local chapter. Those chapters constitute the basic and necessary units of a national movement, which is what we aim to develop.

5. The participation of Mr. Rouviere is most welcome. We need lawyers indispensably, especially those who are always in control of their emotions when they talk and aware that judges and others can take anything that they say to predicate a claim for defamation against them. Judges will present those claims to their fellow judges, who will ensure that the claims prevail because it is an act of "treason" for a judge not to support a fellow judge. No judge wants to be treated by the rest of the class of judges as a pariah, even if the oath that they took was to uphold the Constitution and the laws adopted thereunder rather than to protect each other, the harm to others notwithstanding.

6. You wrote very insightfully thus: "**We need to acknowledge each other and that we all have been scorned by this system. We all have emotions about that that we cannot ignore because that is what is driving us.**"

7. It is precisely emotions that can doom each and all of us. Emotions cause us to lose control of ourselves and lead us to vent invectives against judges and their accessories. That can spell the end of us through one or more suits for defamation.

8. This explains why no abusee will take part in any presentation and will not talk at any press conference. They can help in organizing those events and in the logistics.

9. Only lawyers vetted for their control of themselves, professionalism, and knowledge of what I have written will eventually talk to other people. For the time being, we need to assess lawyers' competence and character. To expose abusers as the top of government we need a team of the best and the brightest. This is not an opportunity for disgruntled lawyers to

highjack a presentation or a press conference to voice their own grievances, whether justified or unjustified, against judges and other lawyers. For the time being, I will be the only voice so as to deliver a consistent message supported by a painstakingly researched and professionally written [3-volume study](#) undergirded by strategic thinking.

10. I am reducing the text that I sent you yesterday to a press release cum flyer on a single sheet of paper so that Mr. Rouviere may consider printing and distributing it to everybody. Through the link▼ in the footer in it, a reader will eventually be able to find the link that you will generate to the presentation.

11. The higher the likelihood that the number of attendees be large and that lawyers and journalist be in attendance, the lower the advisability of allowing any attendee to present themselves. Lawyers and journalists have heard from clients and colleagues stories of outrageous abuse of power. They are likely interested in hearing now only what to do about it. The stories of abusees do not contain anything remotely similar to a plan of action that listeners can join to implement.

12. Nevertheless, you bring up an alternative worth considering, i.e.. "a coffee break type of Zoom" where people can read their up to 500 word story. The problem is that not even abusees are interested in the details of anybody else's story. Why should they, since each thinks that he or she has the most important story ever.

13. Hence, if anybody asks a question that could in the slightest way be interpreted as a criticism of the story, never mind as a diminution of the suffering of the storyteller, a burst of personal animosity will be provoked. We must avoid at all cost a competition for the title "the sufferer of the most egregious abuse unimaginable!"

14. Therefore, the "emotions" that you correctly sensed as driving each abusee should be channeled in a safer and constructive way as a source of energy to organize the proposed [unprecedented citizens hearings](#).

15. My social media accounts have been closed repeatedly, and what is most telling of all, simultaneously. That explains why I do not try to open yet again an account with Facebook and Google. But if you can post on social media what I write, that is a way of circumventing their efforts to deny me direct access to the public.

16. Note that young people have not had occasion to deal with the courts or judges or other abusers. Hence, they are not as receptive to our complaints about courts and judges as middle age people and seniors. Our messaging on social media must take account of these generational susceptibilities.

17. Consequently, my approach to law and journalism students is based, not on an opportunity to tell their story of the abuse that they may have suffered or witnessed, but rather their idealistic desire to bring about a better world.

18. Moreover, we must highlight what students have to gain from participating in a movement that manages to have a notable public impact: When they write about their role in that movement, they will attract the attention of the recruiters that go to their schools to interview students for summer jobs and first job after graduation. As I said before, we lay emphasis on what is in it for the people with whom we are talking, rather than what is in it for each of us individually. That is our approach when we put a message on social media: an opportunity for you to tell in up to 500 words the story of the abuse of power that you have suffered or witnessed.

19. I email my articles to the more than 25,000 email addresses that I have on my emailing list. I am allowed to send only about 500 a day. So it takes me months to send an email twice to the same addressee; in addition, the amount of time that I must invest

to do so is enormous. Hiring a company to do my emailing is very expensive. Even so, the fact that 58,275 people have subscribed to my website as of this morning shows that there is an audience for my articles.

20. However, I have not received a reply from a single journalist, lawyer, or other professionals. No longer do I receive replies from Advocates of Honest Judiciaries with whom I had communicated for years. This gives rise to probable cause to believe that my email accounts -I have four of them- are being intercepted to prevent that likeminded people form a united front against judges and their accessories. See my statistical analysis showing [interception](#).

21. This explains my request that you and your colleagues help in the distribution of my articles by opening each email that any of you receive from me, choosing "Reply All" and clicking "Send". Dear Mrs. Jodi and Advocates of Honest Judiciaries,

Thank you for your very good ideas in red characters and below.

1. It is a good idea to have the attendees introduce themselves, but they should do so in writing. Imagine that you and Mr. Rouviere tell your respective colleagues about the presentation and the number of attendees climbs to 15. Their statement will take too much time and nobody will remember what everyone can do.

2. The presentation should follow the model of a Continued Legal Education (CLE) seminar. I have attended some that have had more than 3,000 attendees. We do not want to establish the precedent that at my presentations attendees can introduce themselves live. They can choose to do so in their up to 500 words story. Making it hard to tell their story will be a way of identifying the most committed attendees, who are willing to put in the effort and time necessary to tell it in writing.

3. The presentation can be had on a Saturday at 11:00 a.m., especially if there is the possibility for people from the West to attend. It is reasonable that they can be up by 8:00 a.m. if they want to attend live a presentation that begins at 11:00 a.m. on the East Coast.

4. In whatever city or state a person lives, there he or she can form a local chapter. Those chapters constitute the basic and necessary units of a national movement, which is what we aim to develop.

5. The participation of Mr. Rouviere is most welcome. We need lawyers indispensably, specially those who are always in control of their emotions when they talk and aware that judges and others can take anything that they say to predicate a claim for defamation against them. Judges will present those claims to their fellow judges, who will ensure that the claims prevail because it is an act of "treason" for a judge not to support a fellow judge. No judge wants to be treated by the rest of the class of judges as a pariah, even if the oath that they took was to uphold the Constitution and the laws adopted thereunder rather than to protect each other, the harm to others notwithstanding.

6. You wrote very insightfully thus: "We need to acknowledge each other and that we all have been scorned by this system. We all have emotions about that that we cannot ignore because that is what is driving us."

7. It is precisely emotions that can doom each and all of us. Emotions cause us to lose control of ourselves and lead us to vent invectives against judges and their accessories. That can spell the end of us through one or more suits for defamation.

8. This explains why no abusee will take part in any presentation and will not talk at any press conference. They can help in organizing those events and in the logistics.

9. Only lawyers vetted for their control of themselves, professionalism, and knowledge of what I have written will eventually talk to other people. For the time being, we need to assess lawyers' competence and character. To expose abusers as the top of government we need a team of the best and the brightest. This is not an opportunity for disgruntled lawyers to hijack a presentation or a press conference to voice their own grievances, whether justified or unjustified, against judges and other lawyers. For the time being, I will be the only voice so as to deliver a consistent message supported by a painstakingly

researched and professionally written [3-volume study](#) undergirded by strategic thinking.

10. I am reducing the text that I sent you yesterday to a press release cum flyer on a single sheet of paper so that Mr. Rouviere may consider printing and distributing it to everybody. Through the link▼ in the footer in it, a reader will eventually be able to find the link that you will generate to the presentation.

11. The higher the likelihood that the number of attendees be large and that lawyers and journalist be in attendance, the lower the advisability of allowing any attendee to present themselves. Lawyers and journalists have heard from clients and colleagues stories of outrageous abuse of power. They are likely interested in hearing now only what to do about it. The stories of abusees do not contain anything remotely similar to a plan of action that listeners can join to implement.

12. Nevertheless, you bring up an alternative worth considering, i.e.. "a coffee break type of Zoom" where people can read their up to 500 word story. The problem is that not even abusees are interested in the details of anybody else's story. Why should they, since each thinks that he or she has the most important story ever.

13. Hence, if anybody asks a question that could in the slightest way be interpreted as a criticism of the story, never mind as a diminution of the suffering of the storyteller, a burst of personal animosity will be provoked. We must avoid at all cost a competition for the title "the sufferer of the most egregious abuse unimaginable!"

14. Therefore, the "emotions" that you correctly sensed as driving each abusee should be channeled in a safer and constructive way as a source of energy to organize the proposed [unprecedented citizens hearings](#).

15. My social media accounts have been closed repeatedly, and what is most telling of all, simultaneously. That explains why I do not try to open yet again an account with Facebook and Google. But if you can post on social media what I write, that is a way of circumventing their efforts to deny me direct access to the public.

16. Note that young people have not had occasion to deal with the courts or judges or other abusers. Hence, they are not as receptive to our complaints about courts and judges as middle age people and seniors. Our messaging on social media must take account of these generational susceptibilities.

17. Consequently, my approach to law and journalism students is based, not on an opportunity to tell their story of the abuse that they may have suffered or witnessed, but rather their idealistic desire to bring about a better world.

18. Moreover, we must highlight what students have to gain from participating in a movement that manages to have a notable public impact: When they write about their role in that movement, they will attract the attention of the recruiters that go to their schools to interview students for summer jobs and first job after graduation. As I said before, we lay emphasis on what is in it for the people with whom we are talking, rather than what is in it for each of us individually. That is our approach when we put a message on social media: an opportunity for you to tell in up to 500 words the story of the abuse of power that you have suffered or witnessed.

19. I email my articles to the more than 25,000 email addresses that I have on my emailing list. I am allowed to send only about 500 a day. So it takes me months to send an email twice to the same addressee; in addition, the amount of time that I must invest to do so is enormous. Hiring a company to do my emailing is very expensive. Even so, the fact that 58,275 people have subscribed to my website as of this morning shows that there is an audience for my articles.

20. However, I have not received a reply from a single journalist, lawyer, or other professionals. No longer do I receive replies from Advocates of Honest Judiciaries with whom I had communicated for years. This gives rise to probable cause to believe that my email accounts -I have four of them- are being intercepted to prevent that likeminded people form a united front against judges and their accessories. See my statistical analysis showing [interception](#).

21. This explains my request that you and your colleagues help in the distribution of my articles by opening each email that any of you receive from me, choosing "Reply All" and clicking "Send". Every email, regardless of its sharing its subject line with other emails from me, has a different set of email addresses in its To: and cc: boxes.
