4. The study describes my out-of-court inform and outrage strategy. It aims to inform the national public about, and outrage it at, judges' unaccountability and consequent riskless abuse of power; collectively demand compensation; and set

in motion transformative reform of the system of justice.

5. A strategic feature is the proposed unprecedented citizens hearings. They are to:

a. be held at university auditoriums, media stations, and other venues of public interest defenders;

b. have professors, journalists, lawyers, experts, and graduate students as their moderators;

c. afford people wherever they are the opportunity to tell in five minutes nationwide in person or through video conference [the story](#) of the abuse that they have suffered or witnessed;

d. present their findings in the first *Annual Report on Abuse of Power in America* at the first-ever national conference on abuse of power simultaneously held at several venues before large live and Internet audiences; and subsequently

through a tour of action-proposing [presentations\(§G\)](#) at universities, media stations, public interest entities, think tanks; etc.;

e. launch the implementation of the [plan of action](#) to develop a *Me-Too!*-like national movement for abuse of power exposure intended to turn academe and the media into a new joint powerhouse of American governance strong enough to bring about transformative change in the exercise of power emanating from, and to be used for the benefit of, *We the People*;

f. prompt the creation of the [for-profit](#) *Institute for Advocacy of Public Accountability*, attached to a top school or news network, that will [research](#), teach, publish, consult, litigate, lobby, etc.

6. This plan is realistic given the Trump administration's executive orders and the vigorous pushback by Harvard, big law firms, and a growing segment of the public. To them must be added principled and opportunistic politicians up for reelection or vying to be elected and facing with trepidation or great expectation the inexorably

approaching start of the primary and mid-term campaigns. They can choose the issue of public accountability and judicial reform to stand out from the pack of candidates by inscribing it on their programmatic platform and addressing it at every rally, interview, townhall meeting, and press conference and release.

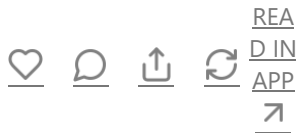

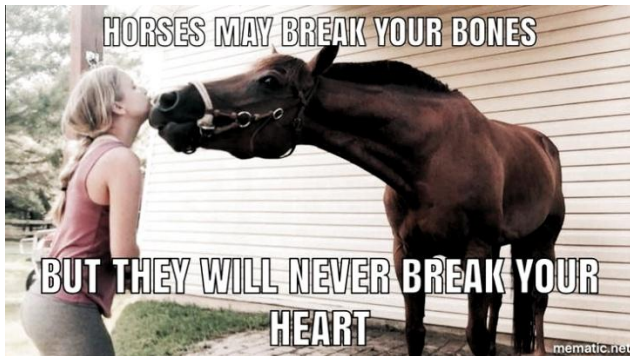

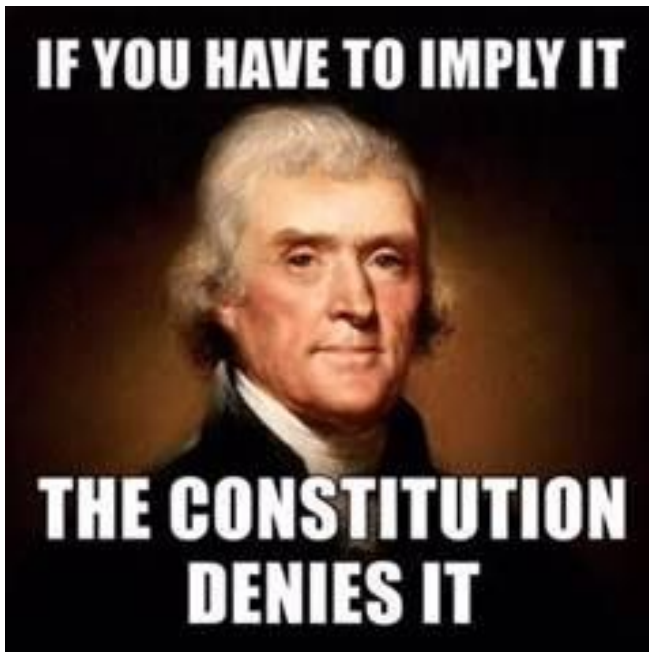
